General Conditions of Entry

1. The event will be played in accordance with the R&A Rules of Golf and Local Rules as approved.
2. All competitors must be of Amateur Status, as defined by the R&A.
3. (a) All entries must be made on the appropriate entry form before the stipulated closing date.
(b) All entry forms must be accompanied by the correct entry fee and be fully-completed.
(c) No entry fee will be refunded after the Starting Sheet has been posted. Any refund will be at the discretion of the Tournament Organiser.
4. Any competitor who is not present on the tee when called upon to start will be disqualified.
5. All competitors are required to play with golf balls on the current R&A list of conforming golf balls.
6. Competitors will not be permitted to ride in motorised buggy carts.
PENALTY for Breach of Conditions 5 or 6 : Disqualification
7. Use of range-finding or distance measuring devices **is permitted**. (Rule 14-3b and Local Rule)
8. All queries and disputes will be settled by the Tournament Committee.
9. Any ties for the winner of the Scratch competition will be settled by a "sudden death" play-off on holes 1 and 9.
10. All prizewinners **MUST** be present at the prizegiving immediately following the end of the tournament.
11. No competitor may win more than one prize.
